Priority:	Complete Streets Maintenance	Include, when possible, complete street design features in resurfacing, maintenance and pavement recycling projects and further enable safe access to public roads for all users.	S09718 (Ryan) A01280A (Rivera)
Supported:	Complete Streets Application	Expands the state's current complete street design principles policy to include all state, county and local transportation projects that are undertaken by the DOT or receive federal, state or both federal and state funding.	S00100 (Ryan) A03180 (Barrett)

Priority:	Defined Safe Passing	Requires drivers to pass bicyclists and pedestrians (including wheelchair users) at a safe distance of min. 3 feet, outside of NYC only. NYC remains "safe distance" under the existing law	S01724 (Harckham) A04346 (Steck)
Priority:	Stop as Yield/Idaho Stop	Proven safety measure that allows cyclists to cautiously treat stop lights as stop signs, and stop signs as yields.	So2643 (May) Ao3986 (Fahy)

	Vehicle Pedestrian Safety Rating	Creates a pedestrian safety rating system for motor vehicles	S00343 (Gounardes) (no same as)

Supported:	Vehicle Miles Traveled Reduction	Establishes clean energy goals of reducing the annual total of vehicle miles traveled within the state by 20% by the year 2050; requires state and local highway projects to comply with reductions to vehicle miles traveled targets. 	NYS Ebike Rebate	Reduces cost of Ebikes and allows more users to access active transportation.	S00314 (Salazar) A00275 (Carroll)
	Ebike Access	Repeal certain provisions of the vehicle and traffic law and would allow ebikes to be ridden anywhere regular bikes can.	S01123 (Cooney) A02627 (Paulin)
	NYS bicycle and pedestrian plan update	Requires the department of transportation to develop an updated New York state bicycle and pedestrian plan adapted from the department's nineteen hundred ninety-seven New York state bicycle and pedestrian plan, to be re-evaluated and updated every five years.
